Course Description

This course is a 10 credit point course within the Masters Qualifying Program. It introduces students to the study of management within organisations. An integrated view of both theory and practice will be examined pointing out applications of social science and implications for management action. An analysis in which organisational performance through a better understanding of effective management of people will also be studied investigating important issues such as an increased awareness of, and sensitivity to, personal skills and employability within a context of globalisation and the need for economic, socio-cultural and environmental sustainability.

Assumed Knowledge

Students must have completed an undergraduate degree in any discipline. It is assumed that students will have basic knowledge of writing in their disciplinary area but may not have higher level research or essay writing skills.

- to provide theoretical frameworks for studying the management of an organisation and to describe their organisational structures, operational characteristics, strategies, performance, development, and effectiveness. Gaining this knowledge will enable students to understand how managers operate in this ever-competitive global business environment.
- 2. to provide a disciplinary framework for understanding the delivery and management of organisations and to appreciate how these frameworks can be used to inform professional practice, identify employee demands and behaviours and assess the impacts and future sustainable orientation of the organisational environment. Achieving these aims will help students gain industry specific knowledge, as well as the skills and knowledge required for their future postgraduate studies.

1. Explain the nature and main features of organisational behaviour and its benefits of management theory adinfluences on management practice.

2. Assess your own management skills and further plan and develop the skills needed to manage an organisation.

4. Demonstrate an understanding of managing organizational practices and organizational structures and processes.

Self-Directed Learning

You will be expected to learn independently. This means you must organise and engage with the course Learning Content (Before Class) even when you are not specifically asked to do so by your teacher. The weekly guide (below) will be helpful to organise your learning. This involves revising the weekly course Learning Content (Before Class) and completing the Learning activities (After Class). It also means you will need to find additional information to evidence your learning beyond that given to you, and to construct your own response to a question or topic. All of this requires careful planning of your time. Expect to spend, on average, at least 10 hours per week including class time for each of your courses.

Task Description: You are required to design an A2-sized poster to demonstrate your visualisation, summarising, prioritising and synthesising skills. A poster is a communication tool that utilises structure, graphics and text to clearly convey complex messages, while being visually appealing and engaging.

In order to complete this task, you are required to design a poster, which clearly addresses the following theme: work-life balance and the organisation of the future.

To be successful in this task, you are required to research academic/scholarly (published in peerreviewed journals) literature and make use of effective and suitable visualisation techniques in order to design a carefully constructed and logical poster, which clearly displays your answer to the above question.

More specifically, your poster should:

- clearly address the question;
- be logically structured and aesthetically pleasing;
- refer to correct material you have read in the literature (you should include a MINIMUM of 5 scholarly references - in-text references and a reference list in APA7th style must be included on the poster;
- present a clear and concise message (in title and other content);
- use relevant visualisation techniques to visually display the message and content of your poster; and
- use text sparingly (a maximum of 250 words, excluding reference list, is permitted).

Please note that web applications such as ChatGPT, Google Translate, Grammarly and Youdao (or equivalent services) are not permitted for assessment creation, translation, or extensive language assistance purposes. Wikipedia, and Baidu, Weibo and WeTalk are not permitted to be used.

2. Evidence of Learning Task 2: Team Case Study Analysis (35%)

Task Type: Written Assignment Due Date: Tuesday 20 August at 9am (Week 7) Weight: 35%, Marked out of: 35 Length: 2000 words Task Description: Working in a team, students will provide a report of the results of their Case Study Analysis demonstrating their ability to critically evaluate the literature. Students will be required to demonstrate

effective academic writing skills. You are to answer the questions relating to the Case Study with 10 academic peer-reviewed

sources that are relevant to your chosen case study in addition to the course textbook.

3. Evidence of Learning Task 3: Individual Self-Reflective Report (45%)

Task Type: Written Assignment and Oral Presentation

Due Date: Friday 20 September at 5pm (Week 11 – written) worth 30% and Monday 23 September (Week 12 – in-class presentation) worth 15%

Weight: 45%, Marked out of: 45

Length: 2,500 words maximum (written) and 3 to 5 minutes (oral)

Written Task Description: This task aims to allow students to explore and develop key capabilities utilising Mintzberg's Managerial Roles (competencies) addressed in the subject. There are three sections to this report:

- 1. A self-analysis/-reflection
- 2. A literature review, and
- 3. A conclusion that outlines an action plan for development

The task must focus on one of the following categories:

- Interpersonal OR
- Informational OR
- Decisional roles

Each topic serves as the experiential basis for individual reflection about current practices as a managerworking in an organisation.

Oral Task Description: Prepare and present a three-minute presentation in class using three to five PowerPoint slides in a '3Minute Thesis Competition' style presentation to articulate and summarise their self-reflective written report.

Criteria and Marking: This will be available on the Course Site found in the evidence of learning tile.

Submission: Turnitin via the course site

In order to pass this Course, students must:

A. Attempt all assessment items,

B. Demonstrate assurance of learning of all learning outcomes through graded Evidence of Learning Tasks.

5.3 Late Submission

An Evidence of Learning Task submitted after the due date, without an approved extension from the teacher, will be penalised. The standard penalty is the reduction of the mark allocated to the Evidence of Learning Task by 5% of the maximum mark applicable for the Evidence of Learning Task, for each calendar day that the task is late. Evidence of learning tasks submitted more than seven calendar days after the due date are awarded zero marks.
